## IMPORTANT INFORMATION

A **Letter Of Agreement** has been negotiated regarding free flying in the controlled airspace around Dunstable Downs. Knowledge of and compliance with the agreement is mandatory. All members must be signed off by a club coach as having received a relevant briefing prior to any flying at that site.

## DECLARATION

- I am a fully paid up member of the BHPA.
- I understand that in the event of any accident or incident howsoever caused, no claim may be made by me, my estate or on my behalf against the DHPC, its committee, coaches or members, or against any landowner/s, and /or site operators.
- To aid efficient distribution of Club information, the DHPC holds its membership details on a computerised database. I understand that this will include my details. I have the right to object to this by means of a written and signed letter stating such objection included with my membership application. Please note however that a member exercising the right not to have their records held on the club database risks not being fully informed of DHPC activities, changes to agreements and up to date information on sites.
- The DHPC are required to disclose membership details to certain parties that have a legitimate requirement to have access to that information. This includes, but is not limited to landowners and / or site operators. I understand that membership of the DHPC is conditional on my agreeing to this disclosure.
- I understand that my details may be published as part of a DHPC membership list, which will only be made available to other club members.
- I confirm that should I receive membership details by virtue of being a DHPC member, I will not disclose such details to any organisations, commercial enterprises, individuals or other parties outside the DHPC
- The DHPC undertake to take all reasonable precautions to ensure that a member's details are not disclosed to organisations, commercial enterprises, individuals or other parties outside the DHPC subject to point 4.
- I promise to abide by the club rules and all laws, bylaws and the countryside code pertaining to any sites administered by The Dunstable Hang gliding and Paragliding Club.
